I immigrated to Australia from Ceylon (Sri Lanka) in 1969, and have long been interested in the Aboriginal and Torres Strait Islander history of my new country. I do not feel comfortable that decisions about the First Nations will be dominated by the votes of other Australians, and therefore want to be guided by the views of the First Nations Peoples.

Section 25 of the Constitution contemplates that certain races could be banned from voting in State elections.

I have since March been in the process of organising a Kitchen Table Conversation in my home, with equal numbers of Indigenous and non-Indigenous Australians, of both sexes and of varying ages, to discuss the differing views of constitutional change, legislation, recognition vs treaty/treaties etc. I will wait to finalise the date of this conversation after my invitees and I have had time to read any final report that comes out of the Uluru meeting beginning 24 May 2017.**
